
# 2024 IMMOKALEE CATTLE DRIVE & JAMBOREE ART & CRAFT VENDOR GUIDE

Experience the pioneer spirit and rich agricultural history of Florida's heartland with a cattle drive and jamboree at the Immokalee Pioneer Museum at Roberts Ranch.

The cattle drive starts along Main Street in Immokalee led by cattle boss Heather Cleckler, decendant of the Roberts family, and leads to Roberts Ranch, a former farmstead listed on the National Register of Historic Places and operated as a Collier County museum. Activities and entertainment kick off when the cows come home and include storytelling, roping and whip cracking demonstrations, traditional food demonstrations, music, craft and food vendors, and so much more. Bring the whole family to the kids' korral with petting zoo, games, and crafts.



### Event Attendance

2023's vendors included 12 cultural organizations, 9 traditional craft exhibitors, 5 food vendors, and 5 vendors from other sectors



2023's attendance reached nearly 3K, with the most represented demographic groups being families and those living in Collier and Lee County.

Event attendance has been increasing, with 2023's event having a 133% increase in attentendees compared to 2022

#### Important Information At-A-Glance

- Vendor fee entitles vendor to one (1) 10'x10' space. Additional 10'x10' spaces can be purchased for an extra \$50 per space. Unless otherwise stated, vendors must supply their own tables, chairs, materials, canopy tent(s), staff, rain protection, and all other necessary supplies.
- Cottage foods, arts, crafts, and other vendors should be consistent with the goals and theme of the event. We encourage all vendors to decorate their booth in a heritage theme.
- All cottage food products offered for sale must be prepackaged with an affixed label that meets Florida Statues 500.80 and US Code of Federal Regulations Title 21, Pt. 10.
- Approved vendors are encouraged to use all promotional outlets that are at their disposal to promote the event and their involvement in it.
- Vendors may not create or sell items bearing the event name or likeness without express prior written permission from event organizers.

#### **How to Submit Application**

Vendors will be notified of their participation status via email within two weeks of their packet being submitted. If approved, instructions will be provided on how to pay the \$100 vendor fee.
